To the Board of Directors, Corporate Secretary, and Chief Legal Officer of Cogent Communications Holdings, Inc.:

Attached is a formal legal demand letter issued on May 23, 2025, by Fiber Network Solutions, Inc., a currently active and duly registered Ohio corporation, and by me in my official capacity as its President, CEO, and Chairman—and as a federally recognized whistleblower in multiple open and active federal investigations.

This correspondence contains serious legal claims and demands material to federal whistleblower proceedings currently under review by:

- The Internal Revenue Service – Criminal Investigation Division (IRS-CI),
- The U.S. Securities and Exchange Commission (SEC),
- The Federal Aviation Administration (FAA),
- The Federal Bureau of Investigation (FBI), and
- The U.S. Attorney for the Southern District of Ohio.

This email and its attached demand must be distributed in full—without redaction, modification, delay, or concealment—to each individual member of Cogent’s Board of Directors, as well as the Corporate Secretary and Chief Legal Officer, with the express exclusion of Chairman Dave Schaeffer, who has been formally noticed in prior correspondence and is a potential subject of material conflict.

Be Advised:

Any failure to forward, disclose, or distribute this legal demand as required—including internal filtering, interception, or omission—may constitute:

- Obstruction of justice under 18 U.S.C. §§ 1505 and 1512,
- Misprision of felony under 18 U.S.C. § 4,
- Retaliation or interference with a federally protected whistleblower under 18 U.S.C. § 1513(e),
- Violation of fiduciary duties under Delaware corporate law, including duties of loyalty, good faith, and oversight,
- Conspiracy to defraud the United States under 18 U.S.C. § 371,
- RICO predicate acts under 18 U.S.C. § 1962(d), and
- SEC disclosure violations, including 17 C.F.R. §§ 240.13b2-1 and 240.12b-20.

You are now on formal notice. This email and its attachment form part of the evidentiary record in pending federal matters. I will treat any non-response, delay, or unauthorized rerouting of this communication as an affirmative act in furtherance of concealment.
